**AUTHORIZING CHANGE ORDER #1 TO CONTRACT FOR NEW EMERGENCY  
GENERATOR FOR SEWER SYSTEM TO FOLEY, INC. NOT TO EXCEED  
ADDITIONAL \$18,825.00**

**WHEREAS**, by Resolution #24-89 adopted on December 16, 2024, the Borough of Stockton awarded a contract to Foley, Inc. for the purchase and installation of a new emergency generator for its sewer system for the sum of \$137,430.00; and

**WHEREAS**, the Borough has determined that additional preparatory work is necessary for installation of the generator, specifically surveying, engineering and permitting services; and

**WHEREAS**, Foley, Inc. has submitted a proposal to complete this work dated May 5, 2025, along with Borough Engineer Colliers Engineering & Design, Inc., for a total cost of \$18,825.00; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available for this purpose, as set forth in the attached certification.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Stockton, County of Hunterdon, State of New Jersey as follows:

1. The foregoing “Whereas” clauses are hereby incorporated as if fully restated.
2. This Resolution, when counter-signed by Foley, Inc., shall serve as a contract amendment to the original December 16, 2024 contract authorized by Resolution 24-89 for the purpose of increasing the contract price by an additional \$18,825.00 for a total contract amount of \$156,255.00.
3. The scope of work for the additional work shall be as set forth in Foley, Inc.’s May 5, 2025 proposal.
4. All remaining provisions of the original agreement between the parties not inconsistent herewith shall remain in full force and effect.
